

**"GO4ARYLEX" CONTEST**  
**OFFICIAL CONTEST RULES**

**1. CONTEST PERIOD:**

The Go4Arylex contest (the "Contest") is being conducted by Dow AgroSciences Canada Inc. ("DAS") for the period beginning January 9<sup>th</sup>, ending on October 31, 2018.

**2. ELIGIBILITY:**

This contest is open to legal residents of British Columbia, Alberta, Saskatchewan and Manitoba who have reached the legal age of majority in their province of residence at the time of entry.

**3. NO PURCHASE NECESSARY:**

No purchase is necessary to enter the Contest or win.

**4. HOW TO ENTER:**

(a) There are two methods of entry

- Participants register at [www.go4arylex.com](http://www.go4arylex.com). Throughout the contest period, participants log in and submit unique contest codes through the website. Each submission results in 4 contest entries.
- Participants are automatically entered when they purchase the following Arylex™ Active brands within the contest period: Pixxaro™, Paradigm™, Cirpreme™ or Rexade™. For each 80 acres\* of Pixxaro, Paradigm and Cirpreme participants receive 4 entries. For each 40 acres\* of Rexade purchased, participants receive 4 entries.
- The odds of winning a Prize depend on the number of submissions entered.

(b) DAS, in its sole discretion, may disqualify any participant or Entry (and the corresponding submission) from the Contest

**5. PRIZES:**

There are four prizes (the "Prizes") available to be won, one John Deere® Z540R Residential Zero-turn Mower, with an approximate retail prize value of \$8500 CAD, one John Deere XUV825M Gator®, approximate retail prize value \$24,000 CAD, one 1025 Sub-Compact Tractor, approximate retail prize value of \$26,000 CAD, and one 3046R CAB Compact Utility Tractor, approximate retail prize value of \$48,000 CAD.
